#### **INTRODUCTION**

CIMAR, a brand of Edappal Hospitals, an exclusive fertility center, offers a complete range of services in gynecology, obstetrics, fertility treatments, breast health, fetal medicine, Neonatology, pediatrics, etc. The hospital was awarded NABH accreditation in 2018 and was the first to get an ISO certification in the district of Malappuram.

Edappal Hospitals – Nursing College is a unit of Edappal Hospital Educational & Charitable Trust. The Edappal Hospitals – Nursing College is affiliated to Kerala University of Health Sciences, Thrissur and is recognized by the Kerala Nurses and Midwives Council and Indian Nursing Council, New Delhi.

#### **OVERVIEW OF B.Sc. NURSING COURSE**

B.Sc. Nursing is a four-year full-time degree program comprising eight semesters, specified by the Indian Nursing Council (INC) & Kerala Nurses and Midwives Council (KNMC) and affiliated to Kerala University of Health Sciences, (KUHS), which prepares nursing graduates qualified to practice nursing and midwifery in a variety of settings in either public/government or private healthcare settings.

#### **NUMBER OF SEATS:** 40 Seats per Year

- Government Quota: 20 seats (50 % of total seats)
- Management Quota: 20 seats (50 % of total seats)
  - Employee Welfare Quota: 04 Seats (10% of Total Seats)

#### ALLOTMENT OF SEATS

#### 1. Government Quota: 20 seats (50 % of total seats)

Government seats are those in which the Director of Medical Education makes allotments. Admission to these seats will be made based on merit. Admission process of allotment to Government merit seats (50%) under Edappal Hospitals – Nursing College will be done by the Director, LBS Centre for Science & Technology, under the supervision of the Director of Medical Education, as per the G.O (MS) No. 75/2018/H&FWD dated, 18/05/2018. Candidates are requested to visit the official website of the LBS Centre www.lbscentre.kerala.gov.in for details

#### 2. Management Quota: 20 seats (50 % of total seats)

Other than Government seats (50%), these are the seats against which the Edappal Hospitals – Nursing College will make allotment. There will not be any type of reservation in the Management seats. Candidate shall pay the Tuition fees and Special fees, fixed by the Government. The eligibility for admission is the same as for the Government quota and the candidate will be selected on a merit basis. Candidates can apply online through the college website www.ehnc.in.

#### 2(a). Employee Welfare Quota: 04 Seats (10% of Total Seats)

Employee Welfare Quota seats are under Management Quota and reserved for the Employees of Edappal Hospitals Pvt. Ltd and Edappal Hospitals Educational and Charitable Trust. The criteria for admission to the Staff Welfare Quota are that the applicant should be the son/daughter of a current employee of Edappal

Hospitals Pvt. Ltd or Edappal Hospitals Educational and Charitable Trust. Parents of such applicants should submit the relevant employment documents along with the application. A separate rank list will be prepared based on merit and the candidate selection will be purely on merit. Candidate shall pay the Tuition and Special fees, fixed by the Government. Candidates can apply online application through the college website <a href="https://www.ehnc.in">www.ehnc.in</a>. Unfilled or Vacant seats of the Employee welfare Quota will be reverted to the Management Quota seats.

#### **ELIGIBILITY FOR ADMISSION**

Candidates seeking admission for B.Sc. Nursing courses should fulfill the following:

Candidates who have passed the Higher Secondary examination conducted by the Board of Higher Secondary Education, Kerala, or an examination equivalent thereto as approved by Kerala University of Health Sciences, Thrissur. Should have separate minimum pass mark for Physics, Chemistry and Biology and 50% marks in Physics, Chemistry and Biology put together.

Applicant should have completed 17 years of age on the 31<sup>st</sup> December 2024. For the proof of age, a self-attested copy of the relevant page of the school record with date of birth such as SSLC/CBSE/ICSE certificate or copy of birth certificate from the appropriate authority should be furnished along with the application form.

\*\*Applicants who have passed the qualifying examination from the universities/ boards outside Kerala shall produce the eligibility certificate from KUHS and the Migration certificate from the universities/ boards concerned.

#### **DURATION OF THE COURSE**

Duration of the B.Sc. Nursing course shall be four years, which is a credit and semester-based program, comprising of eight semesters including an Internship. The maximum period to complete the B.Sc. Nursing course successfully shall not exceed twice the actual duration of the course (Eight years).

#### **SELECTION OF CANDIDATES**

Selection of candidates will be based on a merit list prepared based on the marks obtained in the plus two or qualifying examination. Candidates should bring all the documents in original for verification at the time of admission. Any false information will lead to cancellation of admission.

#### Preparation of merit list

Marks of English, Physics, Chemistry and Biology in Higher Secondary Examination\* will be considered for the preparation of the merit list. If there is a tie, marks for Biology will be taken, followed by Physics and Chemistry. If all these are equal Date of Birth of the candidate will be considered ie, with the person of higher age getting preference over the younger.

\* CBSE/ ICSE Senior Secondary Examination marks will be equated with Higher Secondary marks of Kerala syllabus by approved normalization process.

#### **Publication of Rank List**

The rank lists will be published on the college website www.ehnc.in on the date notified.

#### **ADMISSION**

- Candidates are requested to visit the www.ehnc.in regularly for notifications and announcements.
- Selected candidates for admission under the Management quota are requested to remit the fee into the college account through bank transfer and must bring the fee transaction details.

All the selected students should get themselves vaccinated against Hepatitis B before admission. Certificates to the effect should be produced at the time of admission or before the commencement of the course.

Physical Fitness Certificate (Certified by a Registered Medical Practitioner) should be produced at the time of admission or before the commencement of the course.

#### **COURSE FEE**

The fee structure shown below was fixed by the Govt./Fee Regulatory Committee for the 2024 admission. Any revision in the fee structure ordered by the competent authorities for the current academic year will have to be paid by the candidate.

The annual fee is payable at the beginning of the academic year during each year of the course. Caution Deposit is refundable after the completion of course on submission of Non-Liability Certificate (NLC).

#### **DISCONTINUATION**

- A candidate who gets allotment and admission to a course through the Directorate of Medical Education, Kerala for the Academic Year 2024 25 will be eligible for full refund of fee remitted and he/she need not pay any liquidated damages up to the date fixed by Government.
- The Candidates admitted against Govt./Management seats in Edappal Hospitals Nursing College, on discontinuance of course in the first year, after the cut-off date for closing of admissions fixed by the Govt./INC/KNMC/KUHS are liable to pay liquidated damages and the same shall be collected as per the final decision of the AFRC/Court of Law. In case of discontinuation of the course the certificate and TC shall be released on getting a bond executed by the student with one of his/her parents undertaking that they shall obey the orders that may be passed by the AFRC or Court of Law.
- Candidates admitted against Government seats in Govt./Management seats in Edappal Hospitals Nursing College who discontinue the course after the first academic year, are liable to pay liquidated damages equal to the total amount of tuition fee payable for the remaining year(s) of study. The discontinuation from the course and cancellation of the admission shall be subject to the legal and factual scrutiny of the AFRC/Court of Law when any complaint is submitted before the Committee on such matter.

#### **EXAMINATION**

• Regular University Examination is conducted at the end of each semester and supplementary examination as notified by KUHS. Examination fees shall be remitted by the candidate as stipulated by the University & college from time to time.

#### **ELIGIBILITY FOR APPEARING EXAMINATION**

A candidate must have a minimum of 80% attendance in theory and practical in each subject to appear for the University Examination. A minimum of 80% attendance in all the non-exam going subjects in the concerned semester is essential for registering a candidate for the university examination.

The candidate must secure 50% marks for internal assessment in theory and practical, wherever applicable to be eligible to appear in the university examination of the subject.

#### **RULES AND REGULATIONS**

- 1. Students shall strictly observe professional conduct and high standards of discipline.
- 2. Students should maintain decorum and dignity in the College, Hospital & Hostel.
- 3. As per clause 7 of the Rules and Regulations of the University and Judgment of Honorable Courts regarding the conduct of students on campus, the management has the right to stall organizational activities of students' organization directly or through their member students in campus. An undertaking to this effect be given by the students and their parents at the time of admission.
- Ragging in any form is strictly prohibited in the College and Hostel campus. If any incident of ragging occurs, strict action will be taken as per the latest direction of the Hon'ble Supreme Court.
- 5. Use of mobile phones by the students is strictly prohibited in class, clinics and during working hours. If found in use, it will be confiscated.
- 6. Use of drugs/smoking/alcoholism etc. are strictly prohibited in class/compound/clinics

- /hostel. Any violation leads to dismissal from the College.
- 7. Any type of indisciplinary behaviour (whistling, passing comments, exhibiting posters, spreading rumours, shouting etc.) towards teachers, other students or staff will not be tolerated and will be subjected to major disciplinary actions.
- 8. Any change in the contact address / telephone number should be informed to the College immediately. The college will not be responsible for any delay /non-receipt of information /communication due to the address change.
- 9. The institution shall not be liable for the delay/loss in communication owing to failure of postal / courier service.
- 10. Each student should report for class / clinical at the specified time. Latecomers will not be allowed to attend classes/clinics.
- 11. Students should inform class coordinator / concerned teacher about any inability to attend classes and should submit the leave letter in time. Absenteeism from class / clinics without prior information will be marked as double absence along with other disciplinary actions.

#### **UNIFORM**

Students are to follow the dress code strictly in class and clinical areas as specified by the institution.

#### HOSTEL

Hostel facilities are available for female students. The annual hostel fee is Rs. 45,000/-, it may change according to the fluctuations of prices of commodities in the market.

- Admission to College Hostel will be according to the availability.
- The whole year Hostel fee should be remitted before the starting of every Academic Year.
- Hostel's Caution deposit (One Time) is Rs. 10,000/-. (Refundable at the end of stay subject to no dues certificate).
- Hostel Policy should abide by all the Hostel's inmates. Students are to follow the dress code strictly hostel campus as specified by the institution.

#### **MESS FACILITY**

- Hostel inmates will get a mess facility.
- Mess fees will be collected according to the fluctuations in the prices of commodities in the market.
- The Mess/Canteen dues for the current month will have to be settled before the 5<sup>th</sup> of next month.

#### SHORT TERM COURSES OR TRAINING

The short-term training or courses conducted by the institution in association with other institutions or organizations shall have separate course fees under the expenditures involved.
